ONE MILLION POINTS RAFFLE RULES

A maximum total of 500 tickets will be sold. Drawing will take place at the 24 Hours of Kerr Gala on September 16, 2017. Winner need not be present to win. If not present, winner will be notified by telephone within 72 hours after the drawing. Winner has 45 days to claim their prize. If the winner has not claimed the grand prize within 45 days, they automatically forfeit wherein another winner will be drawn
